

3. Rate Ex-mills on "As is where is basis".
4. GST will be charged extra.
5. Payment will have to be deposited in advance which should be in shape of DD/Cheque/RTGS will be accepted.
6. Loading Unloading & Transportation will be arranged by the purchaser.
7. Weighment at mills weighbridge shall be final.
8. The Mills will have the right to withhold the bagasse for onward supply of bagasse to the CSM's of State as per their requirements/ownconsumption
9. The entire quantity of bagasse is approximate. It will be increase or decrease as per the surplus availability of bagasse.
10. If any eventuality occurs during work, the contractor has to bear the loss/case.
11. The contractor will be responsible for compliance to the provision of labour laws including insurance, EPF Act and Family pension of labour engaged by him for which no extrapayment will be made by the mills.
12. The mills management reserves the right to accept or reject any or all the bids without assigning any reason. Further committee reserve the right to alter any terms and conditions of the tender if required.
